Declaration of Protective Covenants, Conditions and Restrictions:

All wording on page I under Witnesseth have been removed. This is a reference to the initial exhibits to the proposed property and the declarant, which are no longer valid or needed.

12.3 Waiver has been added. Basically says no provisions of the by-laws shall be deemed waived by failure of the board to enforce the same.
